

1795	Original feu to William McKinall or McKinell, mason. [24ft]
1819	Feu charter to William McKinnall, mason in Gatehouse, sasine recorded 1831. Life rent to Agnes Torrens his wife. At that time the property was bounded by tenement of William Black on the East, tannery on south and Richard Murdoch on West.
1832	Passed from William McKinnall, mason in Gatehouse to John McKinnall, shoemaker in Castle Douglas, his eldest lawful son.

John McKinnall lived in High Street (which is in Girthon).

Disposition and assignation by John McKinnall in favour of William McKinnall, shoemaker in Gatehouse.

William was probably John's brother; they lived in the same property in High Street.

1859-60 Anwoth Valuation Roll:

John McCallum, teacher, Newton Stewart, owned a house, shop and garden in Gatehouse that was occupied by William Haye, merchant. *The 1861 census seems to suggest that this was 20 Fleet St.* McCallum also owned a number of properties where gross annual rent was <£4 p.a., *maybe 18 Fleet St.*

We need to be wary here. Ann Nelson is a proprietor of houses in this census. We have her at the same address in the following 2 censuses, largely based on the assumption that the enumerator listed occupants in order of where they lived. Her name is not mentioned in the ownership transactions.

1863 Margaret McCallum now Gourlay passed her share to her brother (*John*?).

1864 Inherited by Duncan McCallum, brother of John McCallum.

1928 Sold to Andrew Rennie, retired farmer.

1930-31 Anwoth Valuation Roll: Andrew Rennie owned and occupied a house in Fleet Street.

1940-41 Anwoth Valuation Roll: Andrew Rennie owned and occupied the house at 18 Fleet Street.

1941 Title of Euphemia Rennie.

1950-51 Anwoth Valuation Roll: Euphemia J Rennie, spinster, owned and occupied the house at 18 Fleet Street.

1953 Sold by executors of Euphemia Rennie to William Evans, transport driver and Isabella McDiarmant.

1960-61 Anwoth Valuation Roll: William J Evans, forestry worker, owned and occupied the house at 18 Fleet

Street.

1973 Hannay trustees.

1976 Sold to Margaret Rainsford Hannay.

1987 Passed to Jessica Rainsford Hannay.
