We have copies of birth, marriage and death certificates for John W. & E.Jane. These give dates, places and parents names.

We have birth, marriage and death certificates for Audrey (ex Family Group Record 2).

We also have copies of birth & marriage certificates for Walter, Mary & Jack + baptism certificate for Jack + death certificates for Mary & Arthur.

It is possible that Esther Jane was born on 23 – 12 – 1899. There is a story that her birth had to be registered by a particular date, but that her mother could not afford the 6d fee. By the time she managed to afford the fee it was a week after the registration deadline so she gave a false date of birth. [Presumably this was only possible if a formal doctor's certificate was not required]

John W. Clamp signed the Rechabite Book in Measham on 13-06-1914, aged 16. Members of the Rechabite Order abstain from alcoholic drink.

On 03-08-1922, aged 25, JWC, collier of Measham was fined 15/- for cycling on a footpath.

JWC died one week before his golden wedding anniversary.




