## 73 High Street — Brae Cottage

Bruachmore & Brae Cottage are part of the old "Brewery Buildings", which also included the brewery itself which has been converted into flats. Part of the "Devil's Elbow" property was probably also included. We are not entirely sure that we have separated the owners and occupants of each part of the brewery buildings correctly.

These 3 families have been identified based purely on the order that they appeared in the census return. Andrew Kirk was clearly in the right vicinity as he was a brewer.

Brae Cottage was sold by John McWilliam to William Ramage along with the remainder of the Brewery buildings and Laurelbank.

1859 Valuation Roll: There were 3 houses and gardens owned by Mrs Janet Ramage. She occupied one herself and

the others were occupied by (a) William Dacre Alder, writer and (b) Grace & Mary Walker.

These properties were not necessarily listed as being in High Street.

No-one with surname Alder lived in Girthon per the 1851 & 1861 censuses. No-one with surname Walker

lived on the north side of High Street per the 1851 & 1861 censuses.

No-one called Tomlinson lived in High Street in 1871 (see 1878 Valuation Roll).

**1878 Valuation Roll:** A house, garden & offices at Gatehouse Brewery was owned by Horatio G Murray Stewart and

the occupant was William Tomlinson, brewer. There was also a house and garden at the brewery

owned by HGMS – this was occupied by Misses Mary & Elizabeth Wilson.

**1881 census** (High Street N25 = empty)

No-one called Tomlinson lived in High Street in 1881 (see 1878 Valuation Roll). Mary & Elizabeth Wilson where teachers who occupied High Street N24, which was probably Bruachmore (next door).
